**THE INFLUENCE OF THE COVID-19 PANDEMIC AND OTHER
FACTORS ON THE ORIGINAL LOCAL GOVERNMENT REVENUE IN

This research aims to determine the influence of the number of tourists, the number of restaurants and eateries, the average length of guest stays, and the COVID-19 pandemic on the original local government revenue in the Districts/Cities of West Java Province from 2017 to 2021. The data used in this study are secondary data obtained from the Badan Pusat Statistik of West Java, Open Data Jabar, and the Financial Statistics of Local Governments in West Java Province. The population in this research consists of 27 Districts/Cities in West Java Province from 2017 to 2021. The method used in this study is a research method that employs panel data analysis techniques and hypothesis testing using Eviews 12. Based on the research results, it can be concluded that partially the number of restaurants and eateries has a positive and significant effect on the original local government revenue. The number of tourists and the COVID-19 pandemic have a positive effect but are not significant, while the average length of guest stays has a negative and non-significant effect on original local government revenue. Simultaneously, the number of tourists, the number of restaurants and eateries, the average length of guest stays, and the COVID-19 pandemic collectively influence the original local government revenue.

ABSTRAK

PENGARUH PANDEMI COVID-19 DAN FAKTOR LAINNYA TERHADAP PENDAPATAN ASLI DAERAH KABUPATEN/KOTA DI PROVINSI JAWA BARAT TAHUN 2017-2021

Penelitian ini bertujuan untuk mengetahui pengaruh pengaruh jumlah wisatawan, jumlah restoran dan rumah makan, rata-rata lama menginap tamu, serta pandemi covid-19 terhadap pendapatan asli daerah di Kabupaten/Kota Provinsi Jawa Barat tahun 2017-2021. Jenis data yang digunakan dalam penelitian ini adalah data sekunder yang didapat dari Badan Pusat Statistik (BPS) Jawa Barat, Open Data Jabar dan Statistik Keuangan Pemerintah Daerah Provinsi Jawa Barat. Populasi dalam penelitian ini 27 Kabupaten/Kota di Provinsi Jawa Barat tahun 2017-2021. Metode yang digunakan dalam penelitian ini adalah metode penelitian menggunakan teknik analisis data panel dan uji hipotesis menggunakan Eviews 12. Berdasarkan hasil penelitian dapat disimpulkan secara parsial jumlah restoran dan rumah makan berpengaruh positif dan signifikan terhadap pendapatan asli daerah. Jumlah wisatawan dan pandemi covid-19 berpengaruh positif tetapi tidak signifikan, sedangkan rata-rata lama menginap tamu berpengaruh negatif dan tidak signifikan terhadap pendapatan asli daerah. Secara simultan jumlah wisatawan, jumlah restoran dan rumah makan, rata-rata lama menginap tamu, serta pandemi covid-19 berpengaruh terhadap pendapatan asli daerah.
