This research aims to know (1) Village Original Income, Village Fund Allocation, and Village Shopping at Villages in Cimaragas Sub-District (2) The Influence of Village Original Income and Village Fund Allocation partially to Village Shopping at Villages in Cimaragas Sub-District (3) The Influence of Village Original Income and Village Fund Allocation simultaneously to Village Shopping in the Villages in Cimaragas Sub-District. The method used in this research is descriptive analysis method with a case study approach. Data collected technique are carried out by reviewing documents about the object under study to obtain primary data, and by conducted library studies to obtain secondary data. The analysis tool is used the Kendall's Tau analysis and Kendall's W concordance analysis with a ratio measurement scale. Based on the conclusions of the research results showed that (1) Village Original Income, Village Fund Allocation, and Village Shopping had a fluctuating at Villages in Cimaragas Sub-District (2) Village Original Income partially had a positive and not significant effect on Village Shopping, while Village Fund Allocation partially had a positive and significant effect on Village Shopping at Villages in Cimaragas Sub-District (3) Village Original Income and Village Fund Allocation simultaneously had an effect and were not significant to Village Shopping at Villages in Cimaragas Sub-District.

Penelitian ini bertujuan untuk mengetahui (1) Pendapatan Asli Desa, Alokasi Dana Desa, dan Belanja Desa pada Desa-Desa di Kecamatan Cimargas (2) Pengaruh Pendapatan Asli Desa dan Alokasi Dana Desa secara parsial terhadap Belanja Desa pada Desa-Desa di Kecamatan Cimargas (3) Pengaruh Pendapatan Asli Desa dan Alokasi Dana Desa secara simultan terhadap Belanja Desa pada Desa-Desa di Kecamatan Cimargas. Metode yang digunakan dalam penelitian ini adalah metode analisis deskriptif dengan pendekatan studi kasus. Teknik pengumpulan data dilakukan dengan meninjau dokumen tentang objek yang diteliti untuk mendapatkan data primer, dan dengan melakukan studi kepustakaan untuk mendapatkan data sekunder. Alat analisis yang digunakan adalah analisis Kendall Tau dan analisis Konkordansi Kendall W dengan skala pengukuran rasio. Berdasarkan kesimpulan dari hasil penelitian ini menunjukkan bahwa (1) Pendapatan Asli Desa, Alokasi Dana Desa, dan Belanja Desa mengalami fluktuasi (2) Pendapatan Asli Desa secara parsial berpengaruh positif dan tidak signifikan terhadap Belanja Desa, sedangkan Alokasi Dana Desa secara parsial berpengaruh positif dan signifikan terhadap Belanja Desa pada Desa-Desa di Kecamatan Cimargas (3) Pendapatan Asli Desa dan Alokasi Dana Desa secara simultan berpengaruh tidak signifikan terhadap Belanja Desa pada Desa-Desa di Kecamatan Cimargas.
